#### 2. Services Provided

Japanese language education (Standard Course, 10-week Course, 20-week Course, 1-year Course, 18-month Course)

### 3. Compensation for services and other estimated amounts

Standard Course (10% consumption tax-inclusive amount)

- Registration fee: ¥16,000 (including a ¥1,000 selection fee) Must be pa id within 14 days from invoice issuance. Selection fee is non-refundable.
- Tuition fee: \(\frac{\pmathbf{Y}}{36}\), 000 (for one week) including teaching materials.

10-week Course (10% consumption tax-inclusive amount)

- Registration fee: ¥16,000 (including a ¥1,000 selection fee) Payable w ithin 14 days from invoice issuance. Selection fee is non-refundable.
- Tuition fee: ¥339,000 (for 10 weeks) including teaching materials.

20-week Course (10% consumption tax-inclusive amount)

- Registration fee: ¥16,000 (including a ¥1,000 selection fee) Payable w ithin 14 days from invoice issuance. Selection fee is non-refundable.
- Tuition fee: ¥644,000 (for 20 weeks) including teaching materials.

1-year Course (10% consumption tax-inclusive amount)

• Tuition fee: ¥1,120,000 (for 40 weeks) including Application fee: ¥15,00 0, Selection fee: ¥35,000, and teaching materials. Selection fee is non-ref undable.

18-month Course (10% consumption tax-inclusive amount)

• Tuition fee: ¥1,570,000 (for 60 weeks) including Application fee: ¥15,00 0, Selection fee: ¥35,000, and teaching materials. Selection fee is non-refundable.

## 4. Payment Periods and Methods

Standard Course, 10-week Course, 20-week Course

- Registration fee: Pay within 14 days from invoice issuance.
- Tuition fee: Pay via Flywire or bank transfer at least 60 days before the start of classes. (If you are applying for accommodation services or other options, payment is also required at the same time.)

1-year Course, 18-month Course

• All fees: At the issuance of the Certificate of Eligibility (or 60 days before the start if the certificate isn't required). (If you are applying for accommodation services or other options, payment is also required at the same time.)

### 5. Service Provision Period

Standard Course, 10-week Course, 20-week Course

Classes start every Monday.

Classes are held Monday to Friday (5 days a week) with 20 lessons per week.

Class hours are:

Morning (9:30 am to 1:10 pm)

Afternoon (2:05 pm to 5:45 pm)

Midday (11:25 am to 3:50 pm)

1-year Course

Courses start four times a year (January, April, July, October) for 40 week s (800 lessons).

Classes are held Monday to Friday (5 days a week) with 20 lessons per week.

Class hours are:

Morning (9:30 am to 1:10 pm)

Afternoon (2:05 pm to 5:45 pm)

Midday (11:25 am to 3:50 pm)

18-month Course

Courses start four times a year (January, April, July, October) for 60 week s (1200 lessons).

Classes are held Monday to Friday (5 days a week) with 20 lessons per week.

Class hours are:

Morning (9:30 am to 1:10 pm)

Afternoon (2:05 pm to 5:45 pm)

Midday (11:25 am to 3:50 pm)

## 6. Items Concerning Cooling-off

(1) Within 8 days from and including the date of receiving the documentation clearly stating the contract content (application guidelines for 1-year and 18-month courses, and invoices for other courses), applicants can cancel the contract by email (referred to as "cooling-off").

(3) In the event that you request cooling-off, this company will not charge you for any ensuing damages or contract cancellation payments. Even in the event that we have already offered a class we will not demand compensation. In the event that we have received payment of tuition or other compensation, we will quickly return this sum in full.

(4) In the event of a refund by our school as stated in (3), the necessary transfer fees shall be subtracted from the amount to be repaid.

### 7. Items Regarding Contract-terminating Cancellation

- (1) After 8 days have passed since the receipt of documentation clearly stating the contract content (application guidelines for 1-year and 18-month courses, and invoices for other courses), the contracts for courses can be canceled at any time.
- (2) In the event that a contract is canceled mid-term, the canceler shall be responsible for the following expenses.

Before the start of classes:

Total amount of (1) and (2):

- ①. ¥15,000 As expenses necessary for concluding and executing the contract
- ②. Other cancellation fees (cancellation fees for transportation or accomm odation, etc.)

After the start of classes:

Total amount of (1), (2), (3), and (4):

- ①. ¥15,000 As expenses necessary for concluding and executing the contract
- ②. Tuition for the completed period of classes (calculated based on the St andard course fee, weekly basis.)
- ③. 20% of tuition as compensation for the period of remaining classes (how ever, this shall be limited to a maximum of ¥50,000)
- ④. Other cancellation fees (cancellation fees for transportation or accomm odation, etc.)

### 8. Preservation Measures with Regard to Advances Received

This foundation requires payment of enrollment fees and tuition in advance of class attendance, but takes no particular preservation measures with respect to this money.
